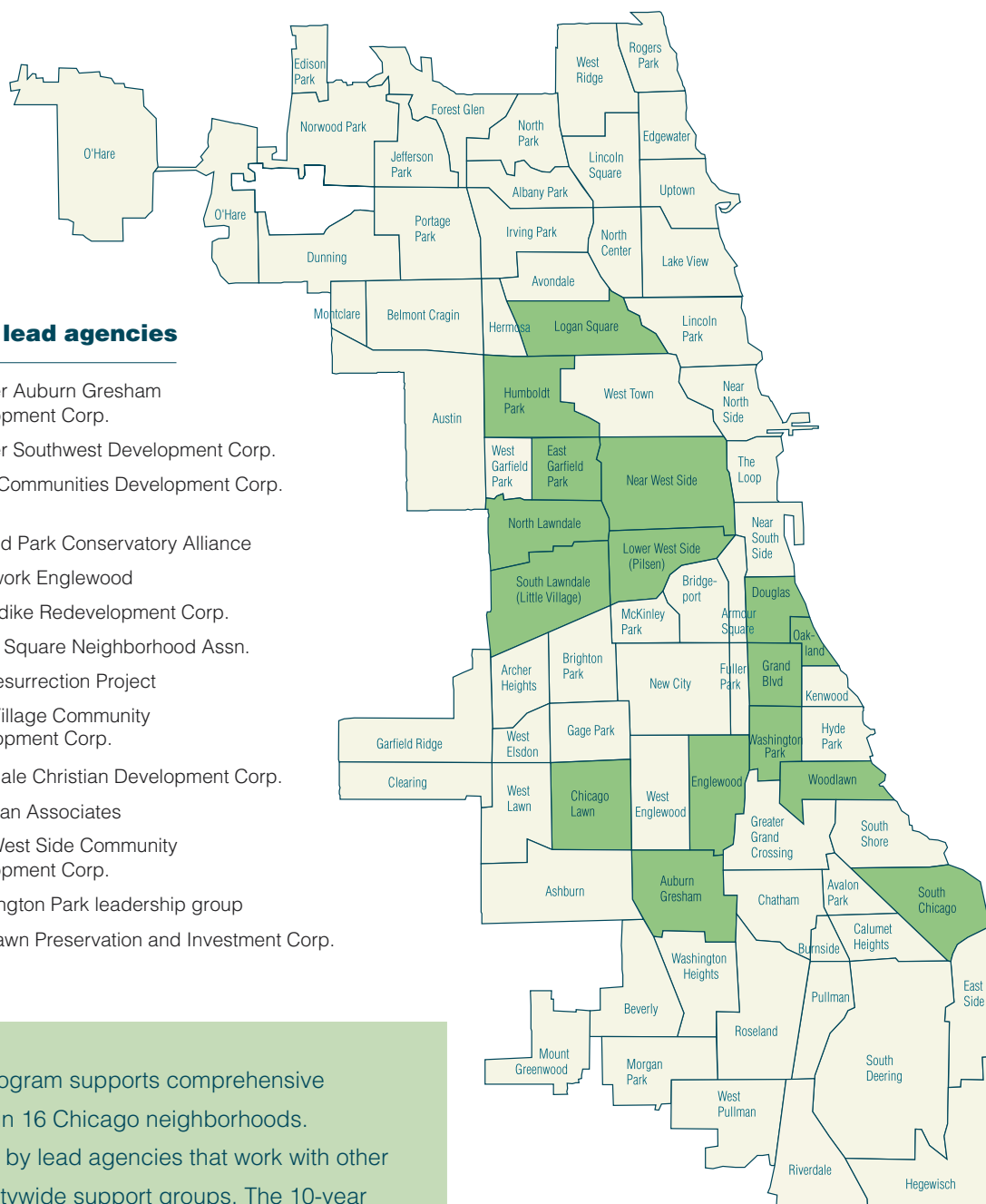

The 10-year effort seeks to rejuvenate decaying communities, bolster those in danger of decline and preserve the diversity of gentrifying areas. Since 2002 MacArthur has committed nearly \$50 million to the Chicago office of LISC for the New Communities Program.
