


The MacArthur Foundation has reported Board and Staff demographic information on its website since 2018. This information has been provided voluntarily based on questions and definitions used by the Foundation. Beginning January 1, 2025, Illinois Public Act 103-0635 (805 ILCS 105/114.15) requires certain not-for-profit organizations, including the Foundation, to disclose specific demographic data about their directors and officers that, in some instances, the Foundation has not previously collected. As of June 24, 2025, however, there has been no guidance from the Illinois Department of Human Rights (IDHR) detailing how to

report the data. The 2025 reporting obligation under the law covers demographic data from calendar year 2024, which the Foundation collected before the law took effect. The data collected by the Foundation generally aligns with the law's requirements. We have not previously inquired regarding veteran status, but to the best of our knowledge, no directors or officers in 2024 were military veterans. Beginning with our next collection of demographic data later in 2025, we will inquire about veteran status as part of the information we gather while we await guidance from IDHR.


Sex and Gender




Race and Ethnicity




Disability Identification
